## Information for Parents Regarding Place Allocation 2020

Dear parents,

A new care year begins in September 2020. Many of you wish to know as soon as possible whether you can safely count on a care place in the crèche, playschool or nursery.

In order to meet this need, the establishment of all institutions will begin in February 2020 with the allocation of places for the **crèches**, **playschool and nurseries**. The first letters of acceptance will be sent by Email or post on the 13th March 2020.

At this early stage, the municipal facilities and independent organizations can only allocate those places that they know will be free for the next year of care.

However, experience has shown that in the course of early summer some parents decide whether to unsubscribe from nursery school or after-school care. Therefore, the facilities will only know later if additional childcare places will be vacant and can be allocated.

That means, places could still be free in the months of April, May, June and July. All parents whose children can attain a place receive confirmation of a place without being asked.

We would like to point out that the allocation of places based on your preregistration is made directly via the respective facilities or organizations and not via the Parents Service Centre (MeKi).
